- amounts for all fees required by KRS Chapter 321 and the fees for services provided by the board. This
- administrative regulation establishes fees for inspections of registered veterinary facilities and
- allied animal health professional (AAHP) facilities.
- Section 1. Payment and Submission of Fees.
- (1) Fees to the board shall be paid by check or money order, or, if available, online
- payment by debit or credit card. Checks and money orders shall be made payable to the
- 16 Kentucky State Treasurer.
- 17 (2) All fees shall be nonrefundable.
- Section 2. Voluntary inspection, re-inspection, and consultation fees for veterinary
- 19 facility and AAHP facility registrations. Payment shall be made to the board in advance of the
- 20 scheduled visit.

1	(1) There shall be no inspection fee charged to a new veterinary facility registration or
2	AAHP facility registration applicant after June 30, 2025, if the inspection occurs within 180 days
3	of the start of operations. <u>In order to schedule an inspection during the 180 day timeframe, the</u>
4	registered responsible party, veterinary manager, or AAHP manager shall contact the board and
5	submit a request for inspection.
6	(2) The registered responsible party, veterinary manager, or AAHP manager of a
7	veterinary facility or AAHP facility may request consultation or voluntary, individualized
8	training from the board in the form of a facility inspection. The board may charge the registered
9	facility a consulting fee of \$125 per hour for the facility inspection.
10	(a) The board shall invoice the registered facility for a minimum of one (1) hour for the
11	facility inspection to be paid in advance of the visit. If less time is used, no refunds for the
12	partial hour shall be granted.
13	(b) Following the single visit for a facility inspection, the board shall within thirty (30)
14	days invoice the registered facility for any time spent at the registered facility in excess of one
15	(1) hour, and time shall be billed in quarter hour (0.25) increments at a rate of \$125 per hour.
16	(c) Failure to pay the invoice to the board within thirty (30) days of the date of the
17	invoice shall be grounds for disciplinary action against the facility registration, registered
18	responsible party, veterinary manager, or AAHP manager.
