

**RE:** **Repeal of COVID-19 Orders**

Following today's announcement by Governor Beshear, the Kentucky Board of Veterinary Examiners (KBVE) hereby rescinds and repeals the following COVID-19 pandemic emergency Orders previously issued by the Board:

- May 17, 2021 – Order Update – Change in face covering requirements
- March 31, 2021 – Order Update
- February 24, 2021 – General Update and Vaccine Information
- September 23, 2020 – Update on Order; Reminder re Required Board Approval for Public Rabies / Health Clinics
- July 10, 2020 – Update on Governor Beshear's Orders Regarding Face Coverings
- June 1, 2020 – Order Update; Protocols for allowing Client Entrance to Buildings
- May 20, 2020 – Update on COVID-19 Order
- May 6, 2020 – Update on Order and Opening Protocols
- April 21, 2020 – Memo and ORDER from the Board, signed by Governor's Office
- March 27, 2020 – Clarifications on the Governor's Directives
- March 24, 2020 – Directive to postpone all non-essential medical procedures
- March 20, 2020 – Memo from the Chairman
