**COMPLAINTS COMMITTEE**

**CALL TO ORDER**

Perry Wornall, D.V.M., Chair, called the meeting to order at 12:20 p.m.

**MINUTES**

A motion was made by Dr. Peterson, D.V.M. to approve the minutes of the September 24, 2015 meeting. Motion, seconded by Gene Smith, D.V.M., carried.

**MONTHLY FINANCIAL REPORT**

Financial statements for the months ending September 30, 2015 and October 31, 2015 were presented to the Board for review. A motion was made by Dr. Wills to approve the financial reports as presented. Motion, seconded by Dale Eckert, D.V.M., carried.

**O&P REPORT**

Robin Vick, Administrative Section Supervisor reported on the December 2015 O&P report from Gordon Slone, Executive Director. The report reviewed payment information for board member travel, itemized hotel bills, administrative services provided by O&P, O&P holidays for December, and a note from Gordon Slone announcing he would be retiring. No further action was required.

## **LICENSURE STATUS REPORT**

A Licensure Status Report dated December 1, 2015 was presented to the Board for review. The report showed there are currently 2,393 active licensed veterinarians along with 313 active licensed veterinarian technicians. The report also indicated 62 licensed animal control shelters and 221 licensed euthanasia specialists. No further action was required.

A motion was made by Dr. Eckert to ratify approved Veterinary, Veterinary Technician, and Euthanasia Specialist licenses issued from September 23, 2015 to December 1, 2015 by the applications committee. Motion, seconded by Dr. Peterson, carried.

## **NEW BUSINESS**

The Board reviewed correspondence from AAVSB regarding Veterinary Continuing Education Tracking (VCET). No further action was required.

The Board reviewed correspondence from Robert L. Eaton, Jr. regarding Guidance for Industry-Compounding Animal Drugs from Bulks Drug Substances. No further action was required.

The Board reviewed correspondence from Carolyn Conrad regarding controlled drug handling. After review and discussion a motion was made by Sam Vaughn, D.V.M. to have legal counsel send a letter in response. Motion, seconded by Dr. Wills, carried.

The Board reviewed correspondence from Cheryl Nelson. No further action was required.

The Board reviewed a list of expired euthanasia specialists and animal shelters licenses. A motion was made by Dr. Vaughn to send cease and desist letters by certified mail to those euthanasia specialists and animals shelters who's licenses have expired. Motion, seconded by Dr. Wills, carried.

The Board held their annual elections for Chair, Vice Chair and Secretary. A motion was made by Dr. Wills for the board positions to stay the same with Perry Wornall, D.V.M. as Board Chair, Eric Peterson, D.V.M. as Vice Chair, and Sam Vaughn, D.V.M. as Secretary. Motion, seconded by Dr. Smith, carried.

The Board scheduled their 2016 meetings for January 28, March 24, May 26, July 28, September 22, and December 1, 2016. A motion was made by Dr. Wills to approve the dates listed above for their 2016 meetings dates. Motion, seconded by Dr. Peterson, carried.

Louise Cooke, KVMA Executive Director presented the board with the 2016 Proposed Revised Statues for submission by the KVMA. After review and discussion, a motion was made by Dr. Peterson for the Board to introduce these changes to the Legislation. Motion, seconded by Dr. Vaughn, carried.

The Board discussed the possibility of regulating veterinary clinics/businesses in order to be able to inspect those facilities and provide a list of what one could have in ambulatory services and clinics. The Board mentioned there were other states that regulated clinics as well as the license. Dr. Wills said he would research some of the other states that regulate the clinics and report back to the board.
